





DESTINATION: DENTS RUN 3895

- ▶ Passive Treatment (2008)
 - ▶ Low-pH Iron Removal
 - ▶ Vertical Flow Ponds
 - ▶ Horizontal Flow Limestone Bed
- ▶ Raw: 1,400 Acid; 275 Fe; 130 Al
- ▶ 86% Fe Removal at Low pH
- ▶ ~30 GPM
- ▶ Treated: -180 Acid; <1 Fe & Al

DESTINATION: PINE GLEN (ACTIVE)

- ▶ PADEP-Moshannon DMO & PADEP BAMR
- ▶ Hydrated Lime - 400 GPM Design Flow
- ▶ 140 Acid; 6 Fe; 16 Al; 30 Mn
- ▶ Bond Forfeiture (Title V) *AND* Abandoned (Title IV)
- ▶ “Historic” Stream Diversion



DESTINATION: PINE GLEN EAST

- ▶ PADEP-BAMR/BCR (Pam Milavec, Rich Beam)
- ▶ Automatic Flushing Limestone Bed
- ▶ Pre-Construction Stream: ~4.5 pH; ~6 Al
- ▶ Post Construction Stream: ~7 pH; <1 Al
- ▶ Removed 12 stream miles from impaired waters list
